Fund profile

ASN Duurzaam Aandelenfonds invests globally in equities of listed companies that meet the strict sustainability criteria of the ASN investment funds. The fund was established in 1993, making it one of the oldest sustainable investment funds in the Netherlands. The Manager tests companies for various sustainability aspects: human rights, including employee rights; the environment and climate change; animal welfare; transparency and social commitment.

It also focuses on the climate performance of the companies in which the fund invests. Companies in the portfolio are reviewed at least once every four years. Due to the explicit investment choices, the fund's return may differ from that of similar, non-sustainable funds.




Indexed rate of return²


