ASN Duurzaam Small & Midcapfonds



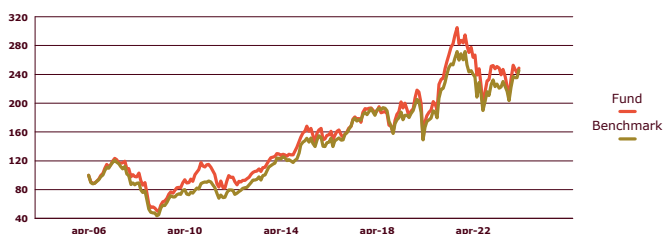
Fund profile

ASN Duurzaam Small & Midcapfonds invests in small to medium-sized European companies that meet the sustainability criteria of the ASN investment funds. The investment universe consists of approximately 120 European small and mid-cap companies, from which the manager selects approximately thirty for the fund portfolio. The fund invests for the longer term: the manager aims to keep the companies in the portfolio for at least three years. The fund offers an opportunity for reasonably high returns, but this is counterbalanced by a high risk.

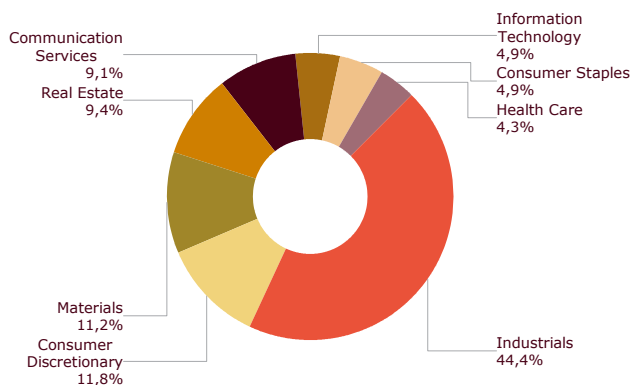

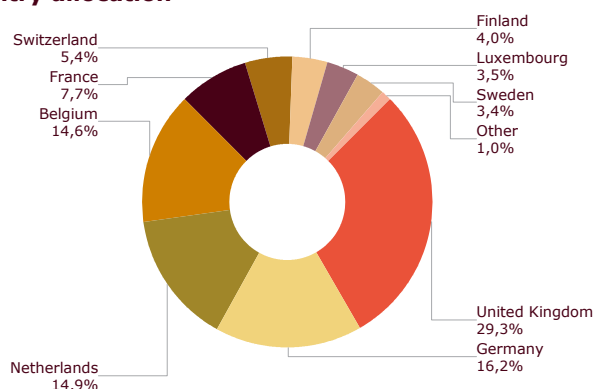
