

STATEMENT

The Hague, the Netherlands, March 26, 2024

Effective as of 9 a.m. CET on the 27th of March, 2024 ASN Groenprojectenfonds ("the Fund) will reopen for investments. As of this moment orders to purchase shares in the Fund will be accepted again. Orders can be placed as of 4 p.m. CET on the 26th of March, 2024. This statement explains the decision to re-open the Fund.

Green institution

ASN Groenprojectenfonds qualifies as a 'green institution'. As a result, private investors in the Fund may be eligible for a tax benefit. The law dictates that at least 70 percent of a green institution's actual activities must consist of investing, directly or indirectly, in green projects, i.e. government-designated projects dedicated to the protection of the environment.

Closing of the Fund

To prevent superfluous fiscal inflow in the last weeks of the year, the Fund has been temporarily closed for purchasing orders since 20 November 2023 as of 4 p.m. CET to prevent that the fiscal inflow would negatively impact the level of investments in green projects so that it would drop below 70 percent. If the percentage of investments in green projects were to drop below 70, the Fund might lose its status as a green institution. This in turn could potentially cause current investors to lose their potential tax benefit.

Re-opening of the Fund

At this point in time, the percentage of green projects is at a level where it is considered appropriate to accept new orders to purchase shares in the Fund. Consequently, ASN Beleggingsinstellingen Beheer B.V. has decided to re-open the Fund for purchasing orders.
