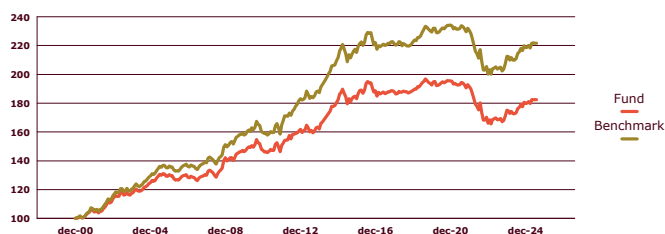
Fund profile

Objectives of ASN Duurzaam Obligatiefonds are financing governments and semi-public authorities pursuing an ambitious climate policy and protecting and promoting biodiversity and human rights and minimising CO2 emissions (measured in tons CO2 per million euros of invested capital). To achieve these sustainable investment objectives, it invests at least 50% in sovereign bonds and no more than 50% in green and social bonds. Green and social bonds are loans issued by governments and semi-government entities used to finance climate-friendly or their sustainability.

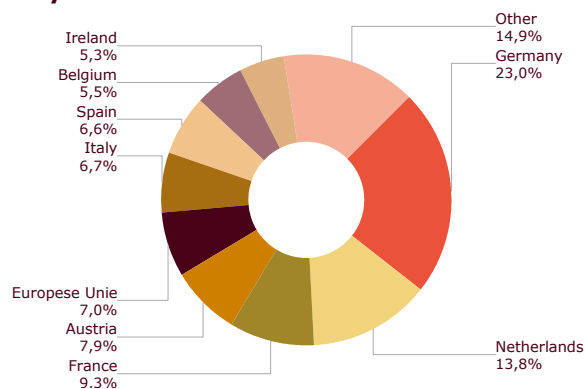

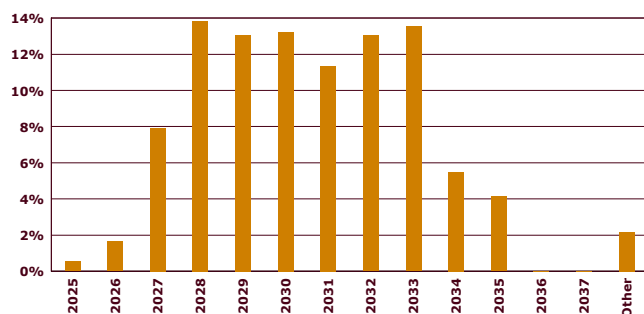
