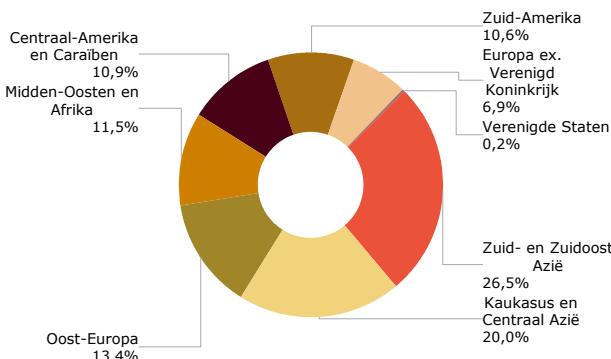
#### Fund profile

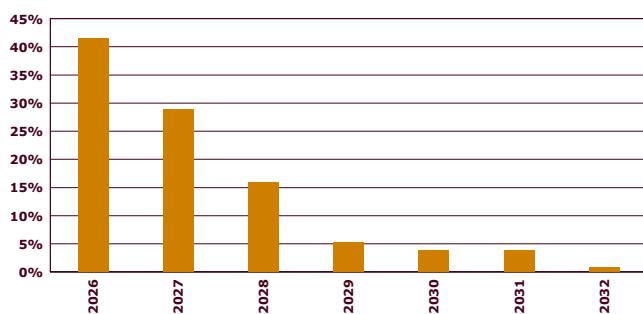
#### Indexed rate of return<sup>1 2</sup>
