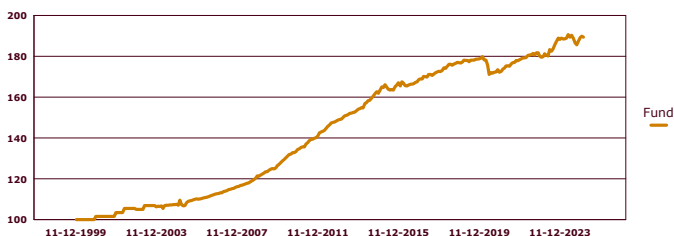
Fund profile

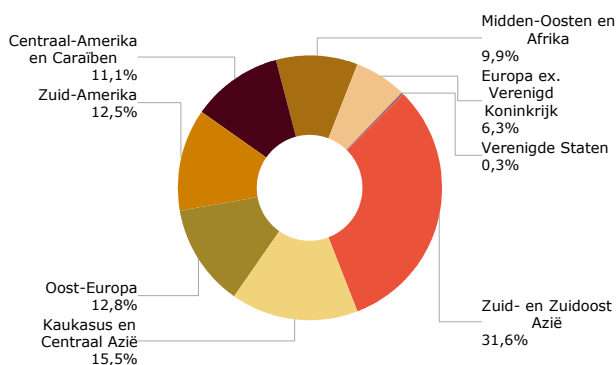

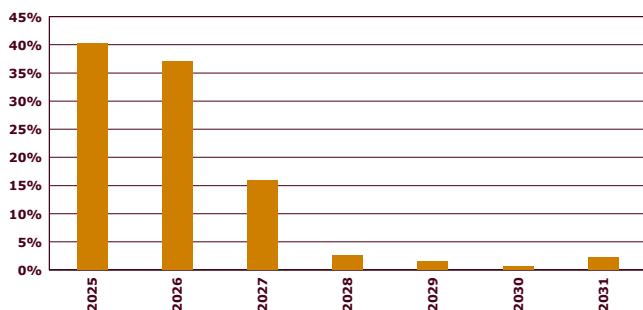
Regions (excluding cash)
