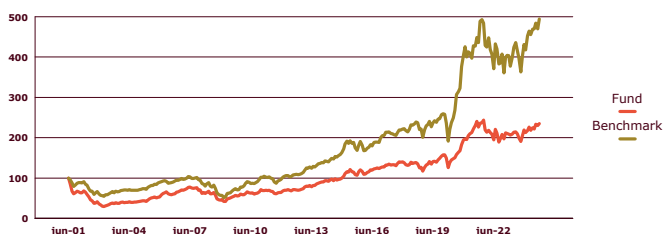
#### Fund profile

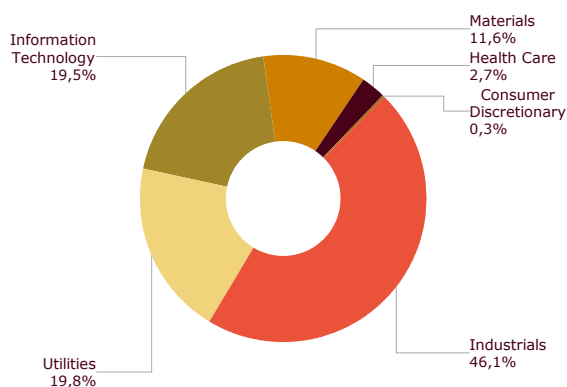

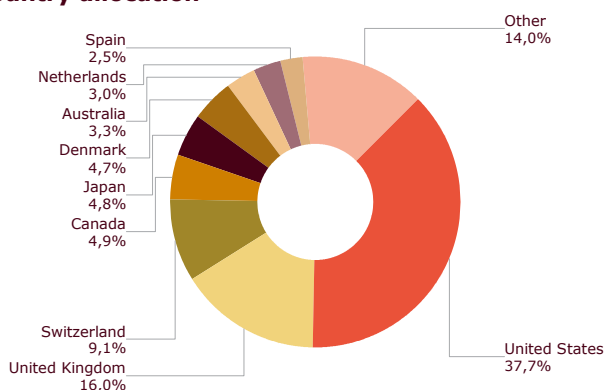
