
The majority of shareholders' meetings are held in the second quarter. We voted for 148 companies. Unfortunately, the released votes at the shareholders' meeting of Rockwool, Vestas Wind Systems, Indutrade, Bravida, Assa Abloy and ProSiebenSat.1 were not accepted due to technical problems.

Four shareholder resolutions were filed with Equinix, Equinix, Sonoco and WashTec AG (2x) in Q2.

- The first involved granting written consent from shareholders. ASN Impact Investors voted in favour.
- The second concerned an advisory shareholder proposal regarding a majority voting standard for the election of directors. ASN Impact Investors voted in favour.
- The third and fourth related to the approval of the capitalization of 50 million in reserves, ASN Impact Investors voted against.

In H1 2021, we voted at a total of 169 company meetings in the ASN Impact Investors accounts, represented by 161 companies. ASN Impact Investors voting policy was applied to all voting decisions made. We voted with management recommendations at 36 percent of the meetings and voted against management recommendations on at least one resolution at the remaining 64 percent of the meetings.






Meeting Distribution by Country - Europe




Meeting Distribution by Country - Americas



Meeting Distribution by Country - Asia Pacific




Meeting Distribution by Country - Africa




The chart below shows meetings voted by region broken down by votes cast for and against.

Meeting Breakdown by Region - For/Against Management




A total of 2,303 voting resolutions were reviewed and voted, of which 2,297 were management resolutions and 6 were shareholder resolutions. As illustrated in the second chart below, we did not support 9.6 percent and we abstained on 0.4 percent of all resolutions.

Type of Resolution - Management/Shareholder






Negative Voting Breakdown Management Resolutions - Europe



Negative Voting Breakdown Management Resolutions - Americas




Negative Voting Breakdown Management Resolutions - Asia Pacific






Negative Voting Breakdown Management Resolutions - Africa
